8.1. Jacqui Milne and Barry Bresner Re: Ghost Hotels

Ghost Hotels

This submission is made on behalf of those residents of Nogies Creek concerned by the proliferation of commercial daily rental operations in the Municipality of Trent Lakes and, more particularly, the operation of "ghost hotels" in areas zoned Shoreline Residential ("SR"). 1. For present purposes, a 'ghost hotel' can be defined as a residential property that contains more than 3 guest rooms and that is used exclusively, or almost exclusively, as short-term rental accommodation. As explained below, the 3-bedroom limit reflects the requirements of the Municipality's existing zoning by-law. 2. We recognize that Trent Lakes has been actively considering regulatory changes and the introduction of a licensing regime for short term rentals (STR's) and has introduced enhanced enforcement measures. We applaud those efforts, but they do not address a core issue – the fact that Zoning By-Law No. B2014-070 (the "Zoning By-Law") does not permit most commercial STR operations, including ghost hotels, in areas zoned SR and that the Municipality has appeared unwilling to fulfill its duty to enforce the existing ByLaw.

Conclusions 28. Residents of Nogies Creek are concerned by the proliferation of unlawful commercial operations, ghost hotels, operating in the SR zone. We purchased and maintain our ownership of our properties in reliance on the Zoning By-Law which ensured that our neighbours would limit the operation of their properties to the residential uses permitted by the Zoning By-Law. We respectfully ask that Trent Lakes take action without further delay to prevent any continuing violations by (i) instructing legal counsel to send a cease and desist letter to the operators of all known ghost hotels in Trent Lakes advising that any continuation of their operations in violation of the Zoning By-Law, including their continued postings on STR platforms, will result in legal proceedings for injunctive relief, and (ii) instructing legal counsel to institute legal proceedings in the event of non-compliance with the cease and desist letters.

Blue Box Program Transition

In 2021, the Ontario government passed a new regulation that shifts the financial and operational responsibility of blue box recycling programs to producers – those that produce and supply blue box materials to residents. (This report is basically what was presented in BRA's October meeting. See agenda for more information.)

In conclusion staff recommends Council enters into agreement with Circular Materials, officially designating them as the PRO responsible for overseeing the new Blue Box Program Framework.

Council accepted that they will use the four transfer stations. They entered into agreement with Circular Materials.

Transfer of Septic Permits from Peterborough Public Health (PPH) to Trent Lakes

Recommendation: THAT Council receive the Transfer of the Septic Permits issuance and inspections from Peterborough Public Health to Trent Lakes; and further, THAT Council approve the date of April 1, 2024, for Trent Lakes to officially begin issuing permits for septic systems; and further, THAT Council approve for that the Discretionary Safe Sewage Reinspection Program be deferred until 2025 with exception of the required mandatory inspections at the water systems. Financial Implications: Additional revenue towards the Protected Services Department Background: In the fall of 2022, Trent Lakes was put on notice that effective November 2024, Peterborough Public Health (PPH) would no longer be accepting any new septic permit applications and further, that all the municipalities within the County of Peterborough will be responsible to handle all septic applications, permit issuance and inspections.

Council approved in principal that the municipality will take it on April 1, 2024. Will be discussed at November budget meeting and final decision is in December meeting.

*An additional 10% contingency on both components of the project will be included in the appropriate budget. An amount of \$200,000.00 has already been included in the 2023 approved budget. The additional amount required for the engineering services will be included in the 2024 budget, with additional funds included in the appropriate future budget for contract administration services.
