EAC Recommendation - Environmental Implications

Recommendation: That Council receive the report from the Deputy Clerk, on behalf of the Environmental Advisory Committee, regarding the EAC Recommendation on Environmental Implications; and further That Council direct staff to add a section to the staff report template for 'Environmental Implications' and to engage with the Environmental Advisory Committee for topics where additional expertise may be of value.

At their July 4, 2024 meeting, the Environmental Advisory Committee (EAC) discussed the addition of an 'Environmental Implications' section to the staff report template. The integration of environmental implications into staff reports has been identified as a priority through the EAC workplan process. This addition to the staff report is intended to encourage staff to reflect and consider positive and negative impacts on the environment that the project may have and to identify any potential risks or opportunities at the outset. This will also serve to inform Council of the environmental considerations and to raise awareness of the impacts from municipal decision making.

Armstrong – I am on that committee. We felt this was a practical but comprehensive way.....that decisions take into consideration environmental implications just as financial implications are taken into consideration.

Janet Klein(Gallery) – Where does money come from? Piccioni – The current one has a budget allocation every year. Current has \$35,000. Because it hasn't been used there is a budget remaining. This year's will be added to it. It is an annual budget allocation.

It does take time to figure our what you can ask for.. Even if you launch in September you won't see grants paid out until September.

Molly.....(gallery) How many times can you apply for this program? Example for facade improvement grant. You can apply for this and then you can decide to do the side façade couple years later. But the maximum grant of \$7500 still applies.

Cadigan – what makes the unit affordable? (This got a bit complicated and I didn't get all the details. Definition is in appendix.)

Braybrook - How was it decided what area would be included in CIP?

Piccioni – We tried to focus on the core mixed use and then a small area around outside where rental units may be possible. It is much better defined than the current plan. Do these properties need community improvement?

How many properties did you identified as possible rental units?

We didn't identify in this way but there are some properties that are part of mixed use properties that are avbl.

Questioned incentive programs. Number four All units must remain rental units for a minimum of 20 years.

Piccioni – we did that for information purposes. Put the 20 years in there so a reader didn't have to flip to the appendix where 20 years is specified.

Could that be amended for clarity? Yes, it can be reduced if council decides. 20 years is standard.

Catherine (online) question about rental component – Is rental residential, commercial, short term what? It applies only to existing rental stock to bring it up to code. It does not apply to short term or commercial. There are other monies for that.

Armstrong – 1. Disappointed that it isn't brought forward that we develop incentives for environmental improvements such as driveway coverings, lighting uses ,landscaping;;

2.Marketing – It requires a laser focused targeted market.

- 3. When we get to budget for 2025 we prioritize the things that you identified for Open Spaces program.
- 4.it is clearly an investment. Number one goal was to improve the core of Buckhorn. This fits in very nicely.

Steve Lattimer (online) couple examples of mixed use properties, please.

Piccioni – property that combines residential and residential use. Many buckhorn properties would fall into that category.

Lattimer – specific name /Piccioni - Any business that has an apartment above it.

Lattimer – Environmental considerations. Examples? Piccioni – flood mitigation measures such as planting native species. Energy efficiency retrofits achieving environmental objectives.

Lattimer – goes back to Braybrook's questin. Is there a mionimum?

Piccioni – Once you specify your minimum term CIP in the appendix it is not amendable. Renter signs apgreement with municipality.

Janet Klein – What happens to grant if a business closes? None. If business is improved it is improved.

Family Health team. That model is something that you have to apply for and be approved for Peterborough has one of the strongest in Ontario. It has been cancelled years ago.

Cadigan – Members of my family have no doctor. Can members of my family get on with Dr.Enow. Richey -That is presently being on the table. We are hoping that Dr.Enow can join the Kawartha Lakes group, too, and serve these people, too.

Armstrong – reviewed facts as to who have no GP. We would need 24 new physicians to fill the gap. Answer – Generally, it is taking two physicians to fill the hole of one.

Peterborough County Detachment Board Terms of Reference

Recommendation: That Council received the report from the Deputy Clerk regarding the Peterborough County OPP Detachment Board Terms of Reference; and further That Council approve the Terms of Reference for the Peterborough County OPP Detachment Board.

The Municipalities and First Nations with representation on the PCODB (Asphodel-Norwood, Curve Lake First Nation, Douro-Dummer, Havelock-Belmont-Methuen, Hiawatha First Nation, North Kawartha, Otonabee-South Monaghan, Selwyn, and Trent Lakes) worked collaboratively to develop the Terms of Reference, attached as Appendix 1, between the PCODB and the respective Municipalities and First Nations. The Terms of Reference are general in nature and are intended to outline the working relationship between the communities represented and the PCODB. Specific policies and procedures are to be determined by the PCODB.

Braybrook – Officially thanks Bianca for stepping up to act as Interim Assistant director. It has helped to move items forward to achieve the quorum Board.

Armstrong –timeline? It is my understanding that Police Services Boards have officially suspended. When will one be functional?

Braybrook –One of the main issues now will be insurance. Working group has been struck without quorum. Community appointees are being used at this time. Just to make recommendations.

Lambshead - timeline?

Braybrook – No clear answer at this time.
